

CAREWare ADAP Import Format

Importing ADAP records can be completed using the Provider Data Import, Data Translation Module, or the HL7 Interface. The following table details the fields that are required for importing ADAP drug payments and the order in which they must appear. NOT IMPORTED – These fields are not used by CAREWare, but values are still brought in from the import file and stored in the import holding tank. This information may be used in reports detailing the original information that is included in the import file.

** - If no value is supplied for this field it will default to Unknown

*** Note – Racial subgroups use a code format of 0000 for Hispanic, 0000 for Pacific and 000000000 for Asian subgroups. Multiple responses for racial subgroups can be imported by entering a yes or no in each placeholder in the code format. For each racial subgroup that is true place a "1" and for each racial subgroup that is false place a "0". (I. e., a client is Puerto Rican and Cuban. You will place a 0110 in the Hispanic Subgroup column.)
